### 2018 First-Year Student Scholarship

SGA scholarship for current first-year students

First time in college (FTIC) students who started at UCF in summer 2017, fall 2017 or spring 2018 (transfer students are not eligible) have the opportunity to secure one of four (4), \$500.00 scholarships to be awarded for the **fall 2018 semester** based on the following criteria:

- 1. FTIC student currently enrolled in UCF course work during the spring 2018 term
- 2. Be in good academic standing (2.00 UCF GPA or higher) at completion of the spring 2018 term
- 3. Enroll in a minimum of 12 UCF credit hours for the fall 2018 semester by Friday, May 4, 2018
- 4. Complete the following activities by Friday, May 4, 2018
  - a. Academic advising session with <u>First Year Advising and Exploration</u> or a <u>College Advising</u> <u>Office</u>
  - b. Participation in **one** of the following academic support or campus engagement activities:
    - i. <u>ACE Coaching Session</u> through the Student Academic Resource Center (SARC)
    - ii. Career Services consultation
    - iii. Office of Undergraduate Research Peer Advising Meeting
    - iv. KnightQuest Peer Consultation
    - v. Engagement meeting with a <u>Housing and Residence Life</u> Coordinator (on-campus housing residents should contact your community office)
    - vi. Complete one of the *Cent\$ible Knights* "<u>Grad Ready</u>" paths (*Paying for College, Money Management* or *Real-World Finance*)

While participation in the above activities will be tracked, you are encouraged to obtain documentation as you complete your advising appointment and other activities. You will be able to upload proof into your application.

5. Submit the scholarship application which will include your response to the following essay prompt (250-500 words, essay submitted as a PDF file):

"What advice would you offer to a new UCF student, knowing what you know now?"

# NOTE: Scholarship recipients must be enrolled full-time (12 hours) during the fall 2018 semester to be eligible for disbursement.
